Dear Members, Donors and Supporters:

"Leading change... transforming the community". For 93 years the Junior League of Richmond has shown how passionate women can lead change and transform a community.

What does transformative leadership in the community mean? It means a commitment to making a difference, rolling up your sleeves and taking action! As in years past, we have done just that and even more. A few highlights include:

-The Clothes Rack turned 70! A new logo, a birthday party, and recognition from AJLI celebrated the impact The Clothes Rack has had and continues to have in Richmond to include the addition this year of pop up shops around the community.

-The Public Affairs Committee was resurrected as a result of the relaunched State Political Action Committee (SPAC). The members in this placement will advocate for those who have been marginalized by human trafficking, a social issue that knows no boundaries.

-The Little Black Dress initiative is an example of the collective impact volunteer leaders and their network can make. Recognizing the lack of access to fresh vegetables in the East End, over seventy JLR members wore the same Little Black Dress for a week to raise awareness of food deserts in our city. They raised \$35,000 to support the purchase of a hydroponic vegetable growing container which will provide fresh vegetables all year round in underserved areas of Richmond.

-Diversity and Inclusion is at the very core of the League. This spring, Carol Goodman, AJLI Board of Directors member; Monica Brinkley Davis, Past President; and Myra Goodman Smith, CEO Leadership Metro Richmond; started the conversation about how we, as an organization and as community leaders, can ensure we are examples of openness and inclusion. As a result the Diversity and Inclusion Board Committee was re-formed.

-Thousands of volunteer hours guaranteed the continued success of the annual Book & Author Event and Touch a Truck. Through these events and the support of individuals and corporate partners, we were able to deliver exceptional programs in the community.

With the sale of the Mayo Carter House in May, the League began a new chapter in its history. The bright red awning on our new Cary Street headquarters announces our presence in this evolving community. While bittersweet, the proceeds from the sale of the house afford the League new opportunities to make an even bigger impact in the community. A committee has been formed to thoughtfully and strategically distribute the sale proceeds to ensure a meaningful and long-lasting League impact. While the house will always be a part of our JLR history, the League is not defined by a building, but by our members, and our commitment to our community.

It has truly been my honor to serve as President of this amazing and inspiring group of volunteers who are dedicated to the Richmond community. I can truly say that through our work and dedication we are leading change and transforming our community.

# COMMUNITY PROGRAM HIGHLIGHTS

## Community Programs Members Enjoy Touch A Truck

This year the Junior League of Richmond made sure that students and families who participated in our community programs were able to attend the 12th annual Touch a Truck at no cost to them or their families. Youngsters from the FRIENDS Association, Woodville Elementary School, Church Hill Activities and Tutoring, the Salvation Army, the Richmond Public Schools Office of Family and Community Engagement and the Peter Paul Development Center all enjoyed a beautiful day at the Richmond Raceway.

Over 200 members of our community attended Touch a Truck and received a complimentary lunch while at the event. We are especially grateful to our friends and partners at Blue Sky Fund who allowed us the use of their buses and drivers to provide free transportation for these children and their families.



Thousands of people attend Touch a Truck each year and the Junior League of Richmond is making sure that members of the community we serve can have the same opportunity to enjoy the event and connect with the folks there that build, protect, and serve our Richmond community!

## Research, Evaluation, and Planning Committee

The Research, Evaluation, and Planning (REP) Committee was formed with the goal of increasing the internal accountability, momentum, and sustainability of the League by 2020. REP evaluates our community programs to ensure they meet the needs of our community partners and serves as the repository for the data collected from our committees. In the inaugural year of REP, members worked with committee chairs to create logic models with a collaborative monthly report. REP worked to define measurable goals for each committee as a format for assessing program effectiveness and optimizing the community experience for our members.

# COMMUNITY PROGRAM HIGHLIGHTS

## Virginia Junior Leagues Annual Leadership Summit

In mid-Fall 2017, twelve members of the Junior League of Richmond joined six other Virginia Leagues at the 2nd Annual Leadership Summit, held in Roanoke. The purpose of this event is to educate and inform members on advocacy techniques while relaunching the Virginia State Public Affairs Committee (SPAC). This year, the focus was on advocacy, membership, diversity, and next steps to rebuilding the Virginia SPAC.

The Summit started with a discussion on "The 'State' of Virginia." This session laid the foundation for all Leagues to have a high-level understanding of trends and challenges facing the communities other Leagues serve. Then, AJLI's high-energy speaker Vicki Clark grabbed our attention with thought-provoking comments on how Junior Leagues can be adaptable to their ever-growing and multi-generational membership.

Breakout sessions gave members a forum to discuss cross-League topics, successes, and best practices. This portion was very informative, as attendees were able to dive deeper into issues and learn how other Leagues handle matters such as recruitment strategy, number of new member classes, member obligations, and so much more.

The Summit concluded with AJLI's Janine Le Sueur and Vicki Clark, and JL Roanoke Valley's Mary Jean Levin sharing tips on the importance of building a statewide coalition and moving forward to relaunch the Virginia SPAC. There was a consensus that Virginia Leagues are ready to relaunch SPAC. The speakers charged each to return to their leadership and begin laying the foundation for SPAC by having a local Public Affairs Committee, discussing issues for advocacy, and selecting two representatives to be a part of the statewide committee.

The Norfolk/Virginia Beach League will host next year's Summit.

## **Pinkie W. Smith Award** Christa Schulenburg



The Pinkie W. Smith Award for Excellence in Volunteerism was established to commemorate the exemplary service and dedication to volunteerism that was so evident in the life of Pinkie Smith.

This year's recipient, Christa Schulenburg, has been devoted to the JLR since 2013 when she first served as a Recruitment Committee Member. She now leads Recruitment as the Chair for the 2018-2019 League year and has also demonstrated her incredible dedication to the League through her service on the Donor Relations and 90th Anniversary Celebration Committees, as a New Member and Active Member Advisor, and as an outstanding Annual Fund Chair.

# LITTLE BLACK DRESS INITIATIVE

This year the Junior League of Richmond embarked on its second annual Little Black Dress Initiative (LBDI). LBDI is week-long, social media-driven fundraising campaign that uses the iconic Little Black Dress (LBD) to raise awareness about poverty and its effects on women in society. Ambassadors wear one LBD for five consecutive days and harness the power of their social media platforms to drive online donations through a charitable fundraising site. This year's campaign focused on food deserts and healthy eating.

**803 Donors | 38 Different States | 74 LBDI Ambassadors**

Our goal was to raise \$35,000. Through the enthusiastic efforts of Ambassadors and support from League members, we surpassed our goal, raising a total of \$36,567. Fundraiser proceeds purchased an EnviraGrow Mobile Learning Center at The City of Richmond's Virginia Cooperative Extension office in the East End. The EnviraGrow Mobile Learning Center will:



- Provide more than 6,000 pounds of fresh produce annually
- Provide Work Force Development
- Reduce the Food Desert in the East End
- Teach Health and Nutrition

We celebrated completion of the Mobile Learning Center on August 9, 2018. Mayor Levar Stoney attended the ribbon cutting and community celebration.

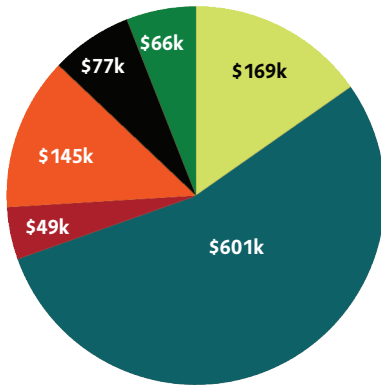

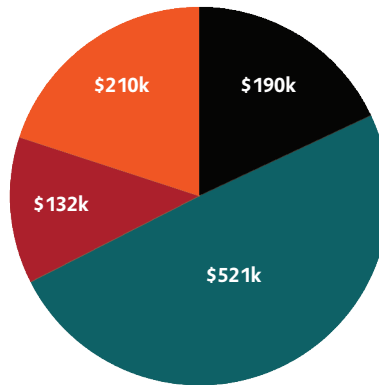

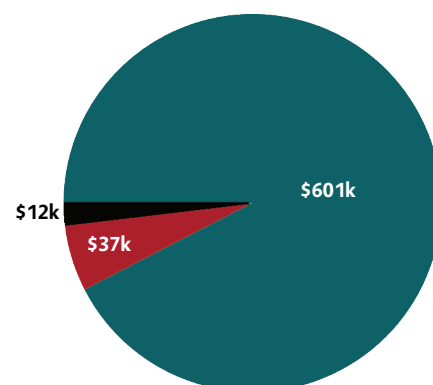
